

- 1. Turn off power and lock out service panel before wiring the control.
- Install at least 2¹/₂" deep switch box for 14-gauge wire or at least 2³/₄" deep switch box for 12-gauge wire.
- 3. Connect cables to switch box and appliance using appropriate connectors. Provide 6" leads inside box and appliance.
- 4. Make electrical connections following diagram on back. Use wire nuts. Make sure both the control and the appliance are properly grounded.
- 5. Tuck wires into switch box and fasten the control to box using attached screws.
- 6. Fasten the switch plate to the control using the short screws from the parts bag.
