



- Control mechanism shall be of the rotating cylinder type with stainless steel plate and 180° rotation, with replaceable non-metallic seats operating in stainless steel lined sockets.
- All operating parts shall be replaceable from the top.
- 1/2"-14 NPSM threaded female inlets and outlets.




* Note: An ASSE 1001 device must be installed at least 6 inches above the level of the highest usage of the handshower and an ASSE 1014 device cannot be subjected to more than a 2-foot head of pressure.
