



## QUARTZ COMPOSITE SINK LIMITED LIFETIME RESIDENTIAL WARRANTY

### TERMS OF THE WARRANTY

**ACKLAND** warrants to the original purchaser that its Quartz Composite Sink (referred hereon as "Sink") will not wear through under normal use. This sink is to be used in indoor, climate-controlled areas only, in a single-family residential setting. The warranty applies to the original purchaser only and is non-transferable.

This warranty is the sole warranty extended for this product. The warranty does not cover:

### IMPROPER INSTALLATION:

Noncompliance with installation guidelines as set forth by **ACKLAND**. This includes issues relating to installing the wrong product, unsuitable support, installation, application, improper conditioning of jobsite, technique, improper adhesives, exposure to extreme temperatures or sunlight during installation, improper spacing or supports, etc.

### IMPROPER USE OR ABUSE:

Includes issues from mishandling the product, physical or chemical abuse, improper care and maintenance, installing residential product in a commercial environment, etc. Damage arising from excessive temperatures, sunlight, chemical exposure, force, impact, or hardness of water. Fading, discoloration, and scratches are not covered. Sink that is not maintained in accordance with **ACKLAND** Care and Maintenance guidelines.

**ACKLAND** disclaims any and all other warranties, express or implied, including but not limited to, warranties of merchantability or fitness for a particular purpose.

**ACKLAND** Sink is a manufactured product, and is subject to variations due to an inherent variability in raw materials and production processes. Certain sinks may have higher levels of variations. All material should be inspected prior to installation. Visual defects or nonconformities apparent prior to installation will void this warranty. All warranty claims must be reported immediately. Failure to report the warranty claim within 14 days of defect discovery will void this warranty.

**ACKLAND's** liability under any theory of liability (whether contract, tort, strict liability or otherwise) shall be limited to the sole and exclusive remedy of replacement of defective goods FOB **ACKLAND** facility or, at **ACKLAND's** option, refund of the purchase price of such defective goods. If product is unavailable or discontinued, **ACKLAND** reserves the right to select and supply a substitute material. The warranty does not cover all other costs, incidental and consequential damage including loss of use of the property.
