### TERMS OF THE WARRANTY

**ACKLAND** warrants to the original purchaser of its porcelain pavers covered under this warranty that the surface of its porcelain pavers will resist permanent staining and fading, subject to your full compliance with the care and maintenance procedures found below.

If, within the warranted period permanent staining or fading is observed that cannot be removed or rectified using recommended methods by a certified landscape/surfaces professional, **ACKLAND** will, at its sole discretion, repair, replace, or remedy the material that is defective. The decision to repair, replace, or remedy is **ACKLAND**'s sole discretion and **ACKLAND** does not guarantee an exact color match of the replacement material.

If the product fails to perform as stated in the warranty, **ACKLAND** reserves the right to have the product inspected by an **ACKLAND**-commissioned inspector. Should the product be determined defective, **ACKLAND** reserves the right to repair, replace, or remedy the defective area with the same color, design, and grade product, if available. If the product is unavailable or discontinued, **ACKLAND** reserves the right to select and supply similar material. Product costs will be covered for the length of the warranty. Warranty coverage for the replacement is limited to the remaining portion of the original warranty and covers only the product cost, FOB **ACKLAND** facility.
