For areas up to 80 square feet.


Warranty:

Power consumption shall be no greater than 20 watts with an efficiency rating of no less than 4.0CFM/watt. The motor will be permanently lubricated, engineered for continuous operation. Light/fan to operate separately or in combination. Light/fan must use a 75W(max), PAR30, BR30LED (14W max), or PAR30L (over tub/shower) Duct diameter will be 4" to 5" expandable. Fan shall be listed for shower enclosure when used with GFCI branch circuit wiring and PAR30L light source. Shall be ETL/ cETL listed for use in insulated ceilings (Type I.C.). Can be used to comply with California Title 24.
