Important Safety Instructions

This manual contains information and instructions for proper handling, operation and maintenance of your Acquabella shower system. Failure to follow these instructions could result in personal injury, electrical shock or fire.

Do not permit children to use this unit unless they are closely supervised by an adult at all times. Supervision is also required when product are used by an elderly or handicapped individual.

Never leave a running shower unattended.

Use this unit only for its intended use as described in this manual. Do not use attachments not recommended by The Manufacturer.

Never operate electrically connected devices in or within 5' of the shower.

To reduce the risk of injury, enter and exit the shower slowly.

To avoid the possibility of personal injury and discoloration of the surface, the inlet water temperature should not exceed 60° C (140° F).

Installation Instructions – General

Read all instructions before installing the shower base or any portion of the shower system. The manufacturer recommends using a professional installer for this product. Installer/product owner is responsible for complying with all state and local codes.

- Damage from shipping or delivery must be reported to carrier immediately. Do not install damage unit(s). The manufacturer is not responsible for damage that occurs during transit.

- Measure shower base on site carefully to ensure proper fit into planned opening. Factory-installed tile flange is 1/16" thick. Account for this thickness for each side with flange when planning final opening size.




TILE FLANGE INSTALLATION

Place shower base on flat surface. Make sure base is free of dust or residue. Use alcohol and a cloth rag to wipe down base.




3 pieces of tile flange are included in box—two "long" pieces and one "short" piece. They are longer than what is required so that they can be trimmed to size.







4. Measure tile flange by dry fitting it. Place tile flange against side of base that needs to be flanged flush with one edge of base. There will be a few inches hanging c other end. Secure flush end with masking tape.




6. Where two pieces of tile flange would meet in the corners, cut rubber edge at 45 degree angle to ensure that the pieces join together without overlapping.




Trim excess off at other end. Repeat for all sides of tile flange, if necessary.




7. Now that all pieces of tile flange are cut to size, lay them on a flat surface and apply continuous bead of polyeurethane construction adhesive between sticky foam strip and rubber edge. Tuck tile flange under base to help hold it down.




9. Line tile flange up against base and securely press in a downward motion, but also press in towards base. Make sure foam is making contact with base on its edge, while the rubber edge should be flush with surface of base.




8. Remove backing for sticky foam strip.



10. To clean up excess polyeurethane construction adhesive on or around base, wait until polyeurethane construction adhesive is tacky before wiping with DRY cloth rag. Use alcohol to remove stubborn spots Alcohol will not allow caulk to cure completely; it should be used last to allow glue to dry as much as possible.



11. Use masking tape along back side of corners to join them together at a 90 degree angle. Apply polyeurethane construction adhesive to seam them together. Remove tape once polyeurethane construction adhesive is fully dried.



MINERAL COMPOSITE SHOWER BASE INSTALLATION

Acquabella shower bases are not equipped with leveling feet and are constructed to install on a flat, level subfloor. The manufacturer recommends a professional contractor to determine the best way to acheive the finished product and function desired.

IMPORTANT! Read all instructions carefully before beginning installation.

Protective Surface Cover The protective cover should be left in place during installation. Peel it back to inspect the product surface, but replace it before continuing with installation. When installing the drain, peel it back once again for access during this process only. Replace protective cover after drain is installed. Once all parts of installation are complete, remove protective cover last.

Shower Base Installation Procedure

- 1. Inspect product thoroughly. Ensure drain location is correct.¹ Make sure the size and color match what was ordered and any necessary tile flanges are in place. Tile flange is ¹/₁₆" thick. Account for this thickness for each side with flange when planning final opening size.
- 2. Check floor surface for level. The area supporting the shower pan must be perfectly level and flat without dips or waves in the surface.
- 3. To size or trim shower base (only allowed for Delgada bases 60" in length or more):
 - Trimming the shower base may void warranty.
 - Do not trim more than 3" from the end of the base.
- Use tile cutting tools.
- Be sure to trim side covered by tile flange.
- Use painters tape to avoid damage when cutting.
- 4. Place shower base into position. Check the shower base to ensure it is level from front-to-back side-to-side, and diagonally. If there are any uneven areas, remedy this with a floor-leveling product prior to installing the shower base. Allow time for any floor-leveling product to dry completely per the product recommendations before attempting to install the shower base. Do not attempt to use shims to level the shower base.
- 5. Re-check the subfloor and shower base for level.
- 6. Install supplied tile flange using waterproof polyurethane adhesive.
- 7. Insert drain fitting into drain opening on tray. Use silicone sealant on the underside of the flange on the drain fitting. Apply silicone to PVC and ABS fittings as thread sealant.

• Do not use plumber's putty on plastic threads, as this may cause damage over time.

Do not allow plumber's putty to come into contact with the surface of the tray.

- 8. Install gasket and female fitting onto threaded male drain until snug.
- 9. Water test before completing installation to ensure proper drainage.
- 10. Apply polyeurethane construction adhesive, such as Sika Pro Select, Loctite PL Premium, or Liquid Nails Heavy Duty to subfloor, as shown in Fig. 1. Also, apply a ¼" bead to bottom of base 4" apart. Do not apply adhesive closer than 2" from outside edge.
- **11.** Lay shower base onto subfloor. Be sure drain is aligned with drain opening in floor. Apply pressure around perimeter of the tray starting with a front corner and working toward the center of the tray. Check level front-to-back, side-to-side, and diagonally.



DO NOT PENETRATE TILE FLANGE WITH NAILS OR SCREWS.

- **12.** Complete drain installation.²
- 13. Use a bead of clear silicone along the top edge of the tray wherever the tile flange is installed to ensure a water tight seal behind the walls.


Tile Flange


Multiple-threshold shower bases include tile flange for up to 3 sides. Tile flange is adhered to the shower base in the field.

Field-installed tile flange is 1/16" thick.

Account for this thickness for each side with flange when planning final opening size.







Acquabella shower bases have a ±½" tolerance and are subject to change at any time. Take all final installation dimensions from the shower base(s).

Care and Cleaning Instructions — Mineral Composite

ABOUT the mineral composite shell

Mineral composite has a stain-resistant, non-porous surface. With normal use, this surface will retain its inherently glossy appearance with only a minimal amount of care.

Cleaning Up After Installation

- Rinse the shower base with cold water after each use.
- Use a rubber wiper to ensure that water does not get stuck in the shower base.

Daily Cleaning Habits

• Use a mild or soft cotton dish cloth (non-abrasive), water and soap with neutral pH (non-greasy) such as Dawn Dish Soap Platinum or Palmolive Dishwashing Liquid

Anti-Limescale Maintenance

- Mix one part limescale cleaner to three parts water (1:3 ratio).
- Remove the grid
- Apply the diluted product over the entire surface with the help of a soft cloth
- Leave to act for 15 minutes
- Rinse with plenty of water
- Perform this periodic cleaning every 10 days

WARNING: Never use rough scrub, solvents, alkaline, acid or abrasive products

General Care

- Do not allow the mineral composite surface to come into contact with nail polish, nail polish remover, Wintergreen oil, dry cleaning solution, lacquer thinners, gasoline, pine oil, etc.
- Avoid using razor blades or other sharp objects that might scratch the surface.
- The manufacturer strongly recommends a professional surface repair person for deep scratches, chips or gouges.
- Damage occurring to the unit during installation is the responsibility of the installer, and after installation, the responsibility of the user.

Residential Limited Lifetime Product Warranty

MTI Baths, LLC ("Manufacturer") offers this Residential Limited Lifetime Product Warranty (this "Limited Warranty") to the original noncommercial purchaser¹ ("Purchaser") of the Acquabella mineral composite shower base ("Product" or "Products").

1. Limited Warranty. Manufacturer warrants to Purchaser that, subject to the terms, conditions and limitations set forth herein, for the lifetime of the Product from the date of purchase, the Product shall be free of defects in material and workmanship. Notwithstanding the foregoing, with respect to Product accessories manufactured by Manufacturer, Manufacturer further warrants that such accessories, including Teak Seats, shall be free of defects in material and workmanship for a period of one (1) year from the date of purchase of such accessory. Slight variations in the appearance of the natural stone shell, and blemishes, air holes or casting marks on the underside of the Product are excluded from this Limited Warranty. Display floor models and overstock sale units are excluded from this Limited Warranty. Drain kits and accessories that are manufactured by third parties are excluded from this Limited Warranty. Oral statements made by Manufacturer or its representatives and written descriptions of the Product other than as set forth in this Limited Warranty do not constitute a warranty on behalf of Manufacturer.

2. Application; Limitations; Exclusions. The Limited Warranty set forth in Section 1 is subject to the following limitations and conditions, and will be rendered null and void in the event of a failure to meet any of the following conditions:
