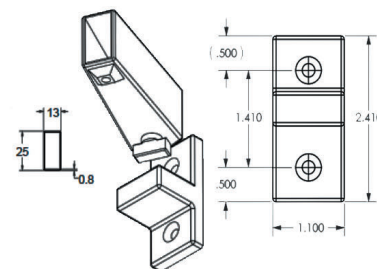
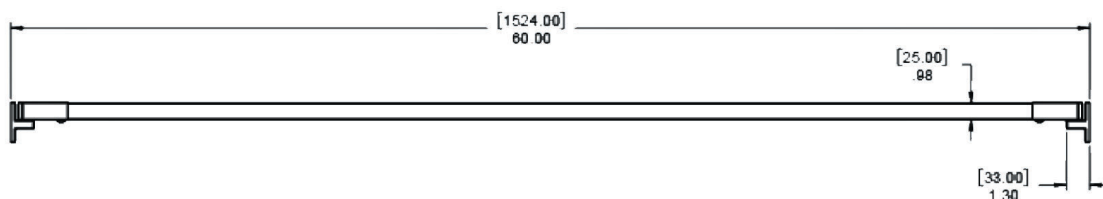

- TOTAL INSTALLED LENGTH OF THE STRAIGHT SHOWER ROD IS 60 INCHES

To cut the shower rod down please follow these instructions: Measure the total opening of the shower/tub enclosure and subtract that number from 60 inches, the remaining number is what will need to be cut from the shower rod. Example: 58 inch opening minus 60 inches leaves 2 inches to cut. It is best to cut equal amounts off both ends, this insures a proper fit.



## INSTALLATION:

Screw the wall brackets onto the wall first. Be sure to measure and level each wall bracket. Once complete attach the bar receivers to the wall brackets via the patented T-Plug and insert the shower rod approximately 2 inches into one of the mounted bar receivers. Slide the shower rod towards the second empty bar receiver mounted on the adjacent wall and insert approximately 1 inch. Use the provided set screws to lock everything in place.
