- **Smooth Bathing Surface.** Vikrell material retains its smooth surface. It does not chip, crack or peel.
- **Uniform Solid Color.** Vikrell is color-molded throughout the product. This material resists wear, does not show tiny scratches and is easy to clean.
- **Durable Performance.** Strong supports are molded into each Vikrell fixture. Units retain their shape and provide years of dependable service.
- **Seamless Appearance.** Interlocking wall joints provide a seamless appearance and watertight seal without the need for caulk or adhesive.

## Care and Cleaning Instructions

### Cleaning Your Vikrell Bath/Shower Module

- Do not** use abrasive cleansers or solvents on Vikrell surfaces.
- Wipe your shower module with a soft cloth after each use to prevent a build-up of soap and scum. Sterling recommends the following products for regular (weekly) cleaning: Spic and Span, Top Job, Fantastik®, Mr. Clean®, Glass Plus® or Gel Gloss.
- If the surface becomes dull, use an automotive-type polishing compound, followed by an application of good-quality paste wax.
- Avoid cleaning products that contain the following chemicals, as they may damage the finish: acetone, ethyl alcohol, amyl or ethyl acetate, sodium hypochlorite, toluene, or phenol.
- Extreme heat such as that generated by cigarettes or portable heaters can damage Vikrell surfaces. Do not use such items near your shower module.

## Sterling Vikrell Bathing Fixture Limited Warranty

### 10 Years Limited Consumer/3 Years Limited Commercial

Sterling® Plumbing, a division of Kohler Co., warrants our Sterling Vikrell™ bathing fixtures to be free of manufacturing defects for 10 years from the date of sale when fixtures are used in residential (owner-occupied) buildings, or 3 years from the date of sale when fixtures are used in commercial (hotels, motels, rental property) buildings.

Whirlpools baths are warranted to be free of manufacturing defects for the same period, except for the pump/motor assembly, which is warranted to be free of manufacturing defects for 1 year from the date of sale.

Sterling will, at its election, repair, rectify or replace a fixture where Sterling's inspection discloses any such defects occurring in normal usage within the time period of coverage stated above. **Sterling is not responsible for installation or removal costs where replacement is indicated.** Damages due to improper handling, installation or maintenance are not considered manufacturing defects and are not covered by this warranty. This warranty is valid for the original consumer purchaser only.
