



Limited Warranty: Tsunami Regenerative Dryer

The following part numbers are covered under the Three Year Limited Warranty:
21999-0710, 21999-0715, 21999-0720, 21999-0730, 21999-0810, 21999-0815, 21999-0820, 21999-0830.

This warranty DOES NOT cover Custom Configured Dryers.

Suburban Manufacturing, Inc. warrants this unit to be free from manufacturing defects from the date the unit is purchased according to the following terms and conditions listed below.

1. The unit must be installed and maintained in accordance with the manufacturers' written recommendations and requirements as they exist;
2. The unit must be used for appropriate applications;
3. The unit must not have been altered from its original state;
4. The unit must be registered with Suburban Manufacturing, Inc.

Three Year Warranty

When installed, operated and maintained according to all supplied instructions, Suburban Manufacturing, Inc. warrants the Tsunami Regenerative Dryer bases, filter housings, and Moisture Minder® automatic drain valves for a period of three years.

Ninety Day Warranty

When installed, operated and maintained according to all supplied instructions, Suburban Manufacturing, Inc. warrants all other componentry including float drains, PLC's, and media towers for a period of ninety (90) days.

This warranty covers ONLY defects in material or workmanship.

Limitation of Remedies: Under no circumstances shall Suburban Manufacturing Inc. be liable for incidental or consequential damages or expenses of any kind, including loss of income or profits arising out of or in connection with this contract or with the use of delivery of products furnished hereunder. Suburban's liability and Buyer's exclusive remedy for any claims arising out of the products sold hereunder shall be limited to replacement or repair of nonconforming goods or payment in an amount not to exceed the purchase price thereof, at Suburban Manufacturing's option. The product must not have been altered from its original state. Any portion of the product found defective in material or workmanship will be repaired or replaced, at the Suburban Manufacturing's option, without charge for parts or labor, providing the unaltered product is returned to the manufacturer, shipped prepaid, within the time period set forth in this warranty and provided further that Suburban Manufacturing Inc. establishes that the product is defective in its material or workmanship.

This warranty specifically does not apply to and will not pay for:

1. Any unit which has been altered from its original state by the customer or anyone acting on behalf of the customer other than the manufacturer;
2. Repairs necessitated by accident, abuse, or failure to use the product in a manner for which it was designed;
3. Failure by the customer to follow the normal installation, application and maintenance requirements of the manufacturer;
4. Loss of use of any system of which this unit is a part, loss of time, inconvenience or any other incidental or consequential damages sustained by the customer.
5. The cost of an on-site service technician to instruct or assist the user in correct product installation, operation, or maintenance.
6. The cost of a service technician to clean or maintain the product.
7. Expendable items that can wear out from normal use within the warranty period, including but not limited to filter elements.
